



## Privacy Policy

Rich May, P.C. (“we” or “us” or “Rich May”) is committed to protecting your privacy online. This Privacy Policy explains how we protect personal data that we collect and use at the website we operate at [richmay.wpenginepowered.com](http://richmay.wpenginepowered.com) (the “Site”).

### Information we collect and how we collect it

When you visit our Site, we may collect personal information such as your name and e-mail address that you voluntarily provide to us when you complete a contact request form or subscribe to our newsletter or other content.

In addition, the Site collects information automatically. As you navigate through and interact with our Site, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions and patterns, including, how you arrived at our Site (including the URL you came from, if you arrived from another site), your network name, your browser type, which type of Internet browsing device you are using, the country, state, and city where your server is located, and the pages that were viewed during your visit to our Site.

We do not use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). We do not respond to Do Not Track (DNT) signals/requests.

The information we collect automatically is statistical data and does not include personal information, but we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Site and deliver a better and more personalized service.

This site uses Google Analytics features to track acquisition information to improve services on this website. These features are not used to generate information about a user’s age, gender and interests. This information is tracked using various third-party cookies from Google Analytics, Google DoubleClick, and YouTube.

## How we use and disclose your information

We use the information we collect solely for our own business activities and to improve the Site. We may use the aggregate or statistical website information for security and maintenance purposes. We also use authorized third parties to collect, process and track such information.

We will use your personal information to provide you with services and information you request, with your consent, or to fulfill an agreement with you. We may also use personal information to satisfy a legitimate interest of Rich May, including but not limited to, determining fraudulent activity, direct marketing with users based on their relationships with us, and other communications users would reasonably expect to receive from us. All personal data will be processed for lawful purposes as described in this Privacy Policy.

Information voluntarily provided to us may be used to contact you through direct marketing services including MailChimp about our services that may be of interest to you. If you do not want us to use your information in this manner, please contact our Privacy Officer (see Contact Us below for details on how to contact our Privacy Officer).

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction. We may share your personal information with our third-party service providers, including but not limited to website developers and hosts, advertising agencies, and other service providers, whose use of your information is limited to providing services to us. We may disclose your personal information to respond to requests from law enforcement, to respond to subpoenas, court orders or other legal process, as required by law, or to protect Rich May or defend against legal claims. We also may disclose your personal information in connection with a possible sale of our business or assets, or merger with another company. Any third party to which Rich May transfers or sells related assets will have the right to continue to use the personal and other information that you provide to us.

Finally, we do not sell or rent personal information to others. We use your information only for the purposes described in this Privacy Policy.

## Children under the age of 13

The content of our Site is not targeted to or intended for, children under 13 years of age. Rich May does not market services to this age group and does not knowingly collect personal information from children under 13. If you are under 13, do not use or provide any information on this Site or on or through any of its features, or provide any information about yourself to us, including your name, address, telephone number, e-mail address or any screen name or user name you may use. If we learn we have collected or received personal information from a child under 13 without verification of parental consent, we will

## California privacy rights

California Civil Code Section § 1798.83 permits users of our Site that are California residents to request certain information regarding our disclosure of such residents' personal information to third parties for those parties direct marketing purposes. Under the CCPA, you cannot be discriminated against for exercising your rights to access or request erasure of your personal data.

## UK and European Union privacy rights

To process your personal information, we rely on the following legal bases: (i) pursuant to your consent, which is provided by acknowledging your agreement with our Cookie and Privacy Policies; (ii) to perform the contract we may have with you to provide the services you have requested from us; (iii) for compliance with legal obligations to which we are or to which we may become subject (including tax obligations, and requests from law enforcement agencies or other competent authorities with jurisdiction over us and our Site); and (iv) for the purposes of our legitimate interests in providing the Site to you, making suggestions to you regarding service offerings, monitoring the Site for fraud or misuse, and ensuring the functionality of our Site.

To the extent that you have provided consent for us to process certain of your personal information, you may withdraw your consent at any time. You also may contact us at any time to request that we cease some or all processing of your personal information, whether or not such processing was

the result of your specific consent or some other identified legal basis. There is no legal consequence to you if you refrain from providing or otherwise revoke consent to our processing of your personal information. However, please note that our ability to provide the Site and other services to you may be impacted if you do not share certain personal information with us in connection with your use of the Site or other services.

You may request that we confirm whether we are processing your personal information, and you may request access at any time to your personal information over which we have control. You may also, at any time, request that we delete or erase your personal information, unless applicable law requires us to retain such information or have other legitimate grounds for continuing to process your personal information. You may also object at any time to our use of your personal information to provide direct marketing. We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration and disclosure. However, no one can guarantee any data transmission over the Internet to be 100% secure. As a result, we cannot ensure or warrant the security of any information transmitted to our Site over the Internet, and Rich May is not liable for the illegal acts of third parties, such as hackers.
